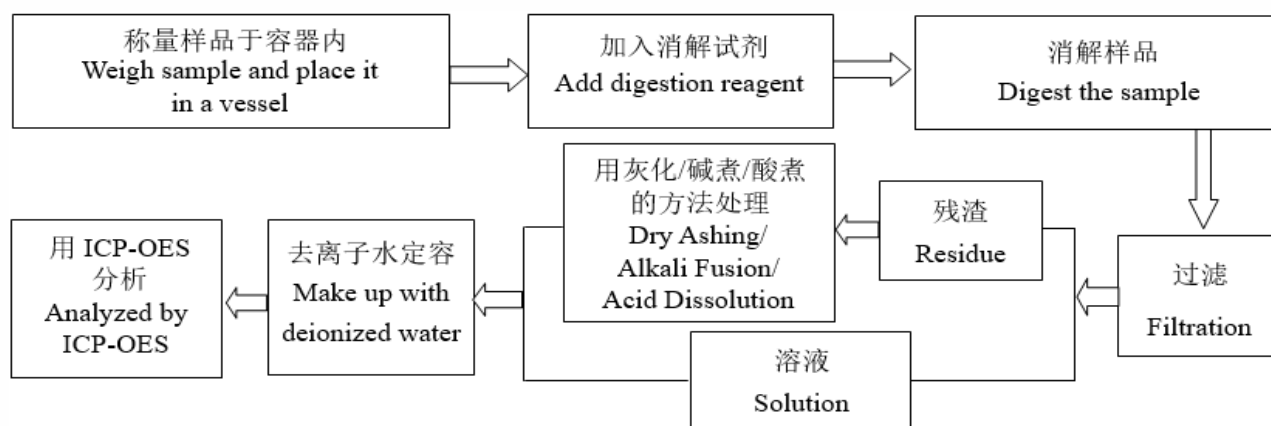

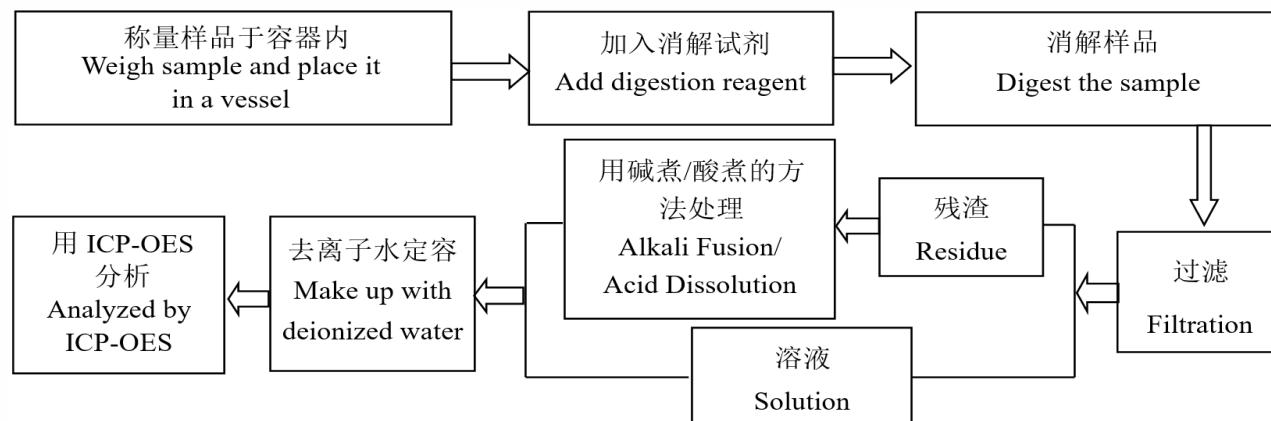

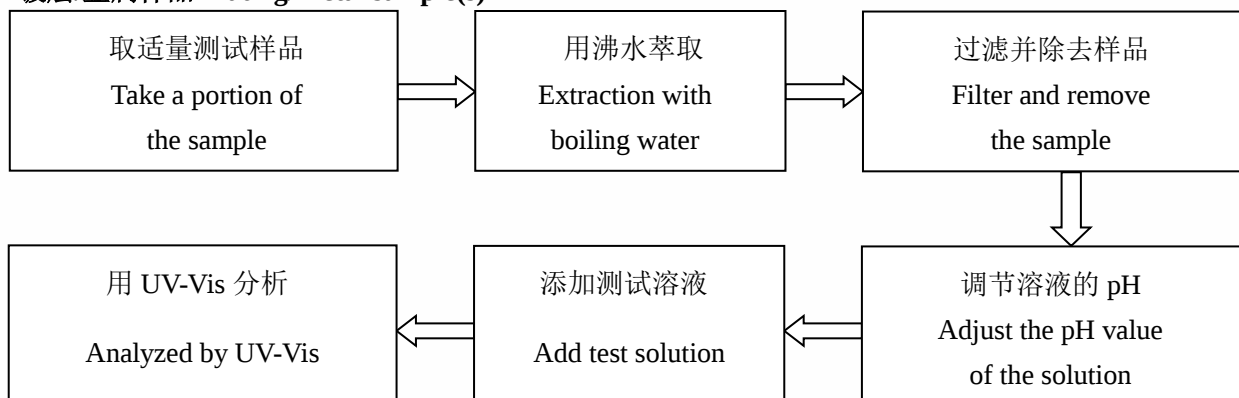
2. 汞 Mercury (Hg)

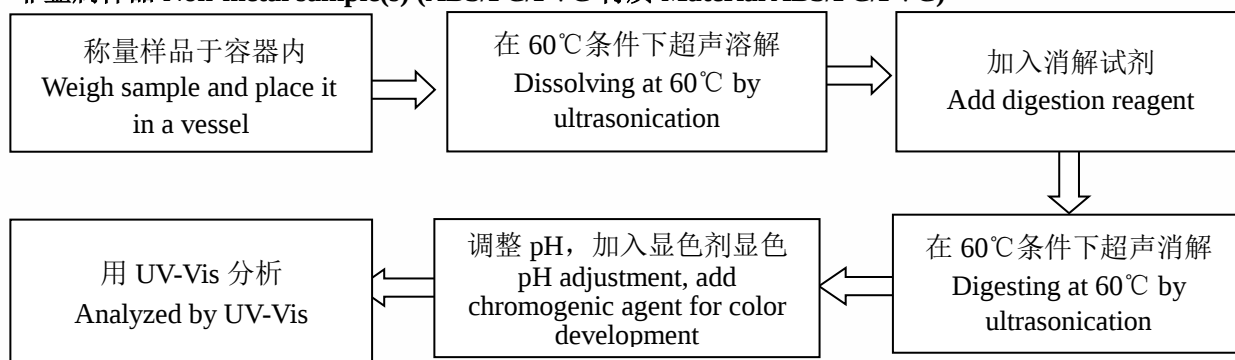

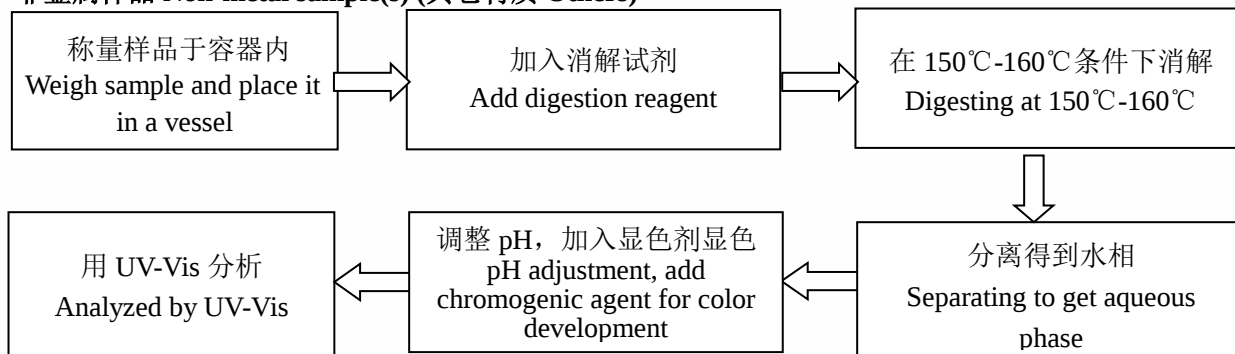

非金属样品 Non-metal sample(s) (ABS/PC/PVC 材质 Material ABS/PC/PVC)

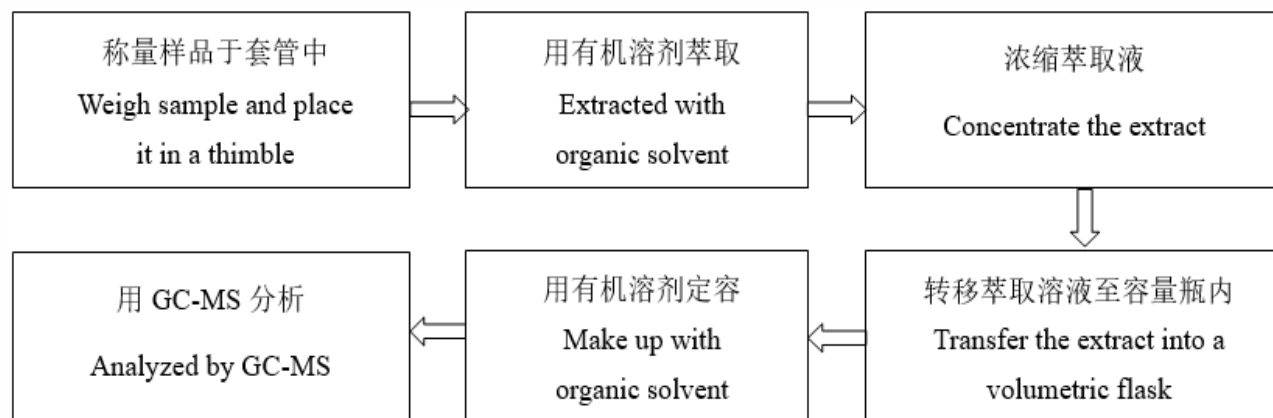

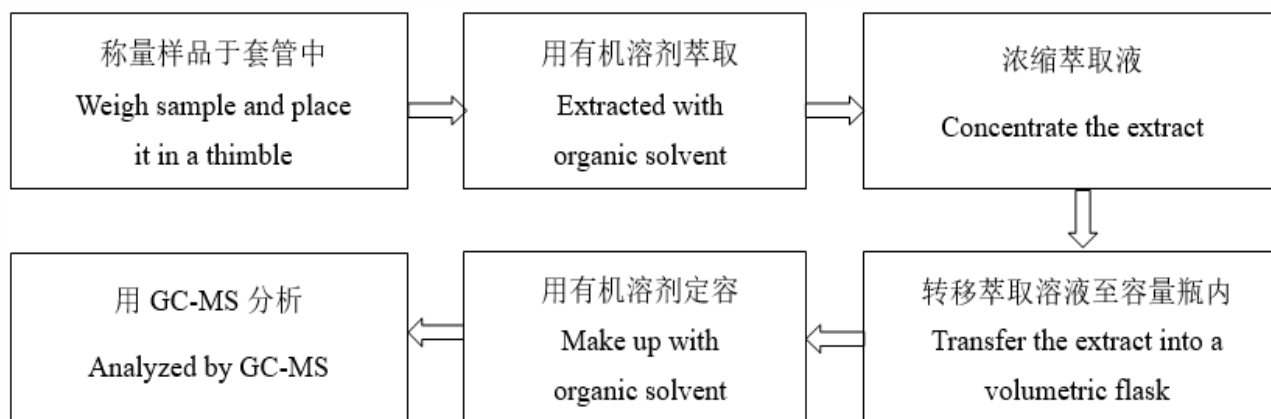

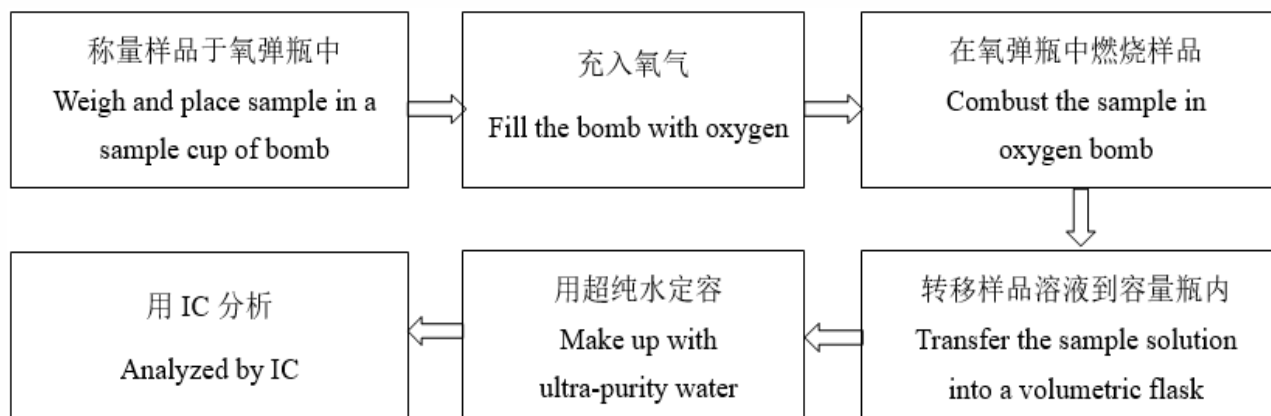
