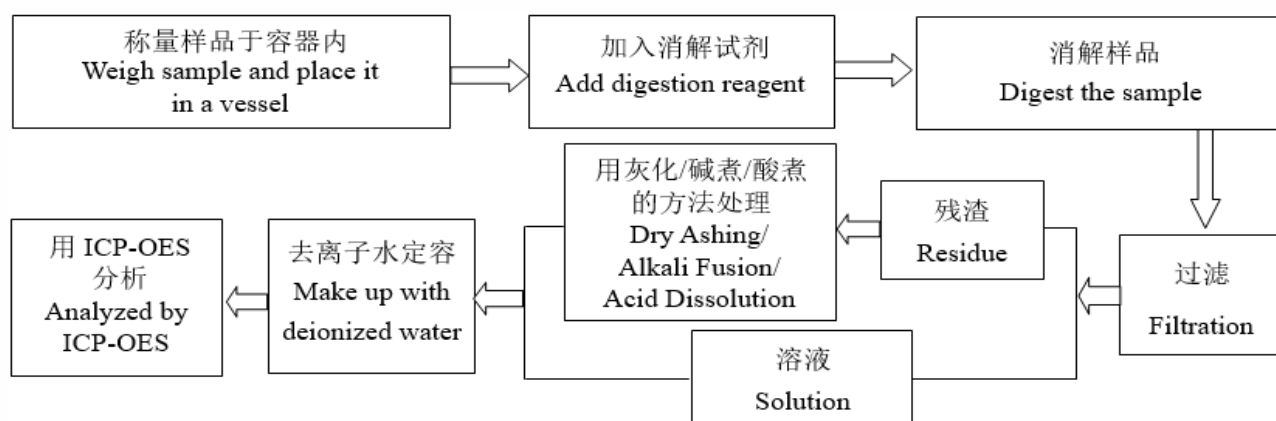

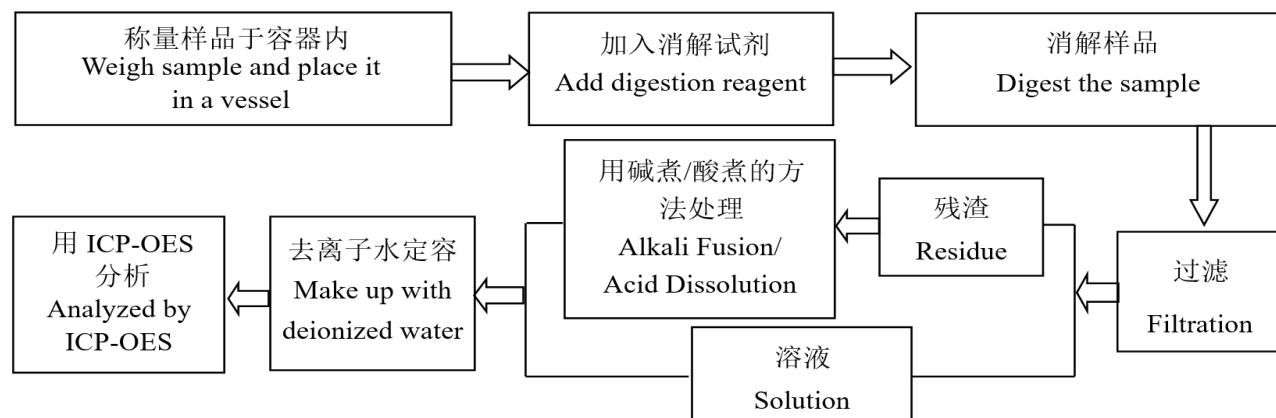

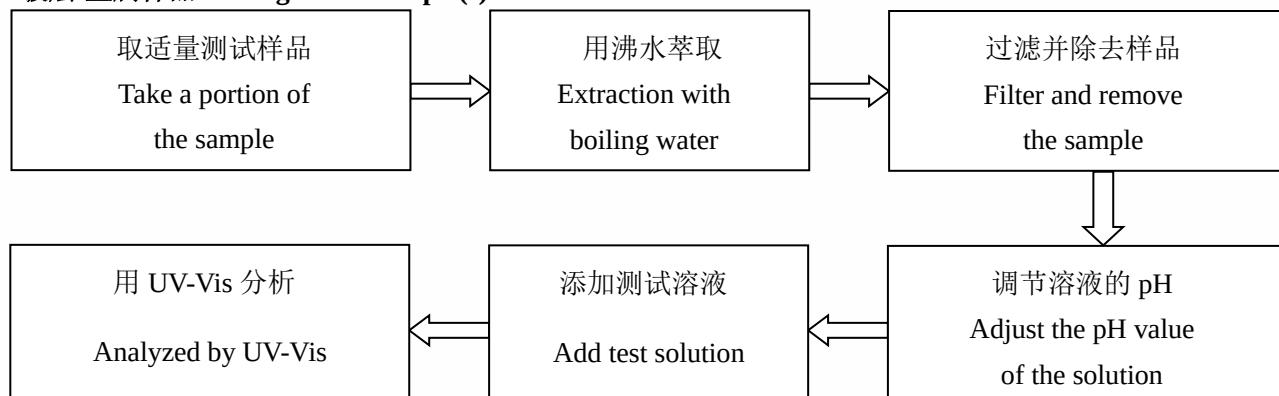
2. 汞 Mercury (Hg)

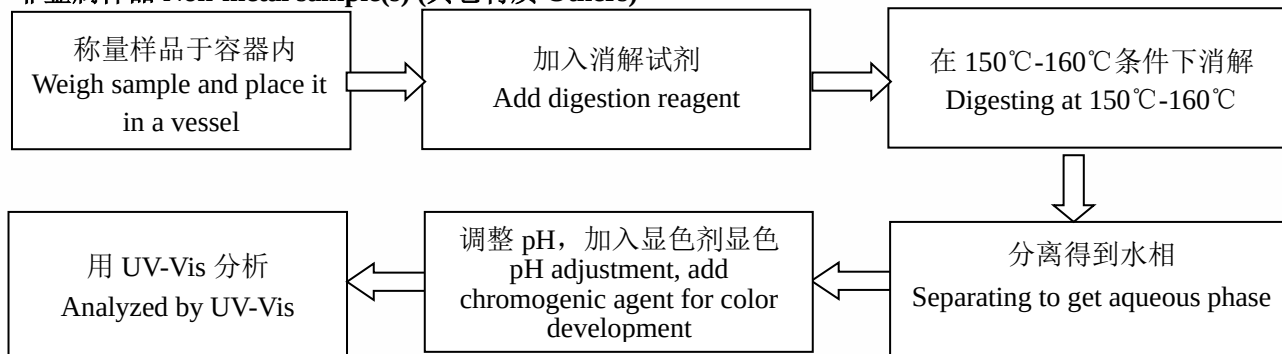

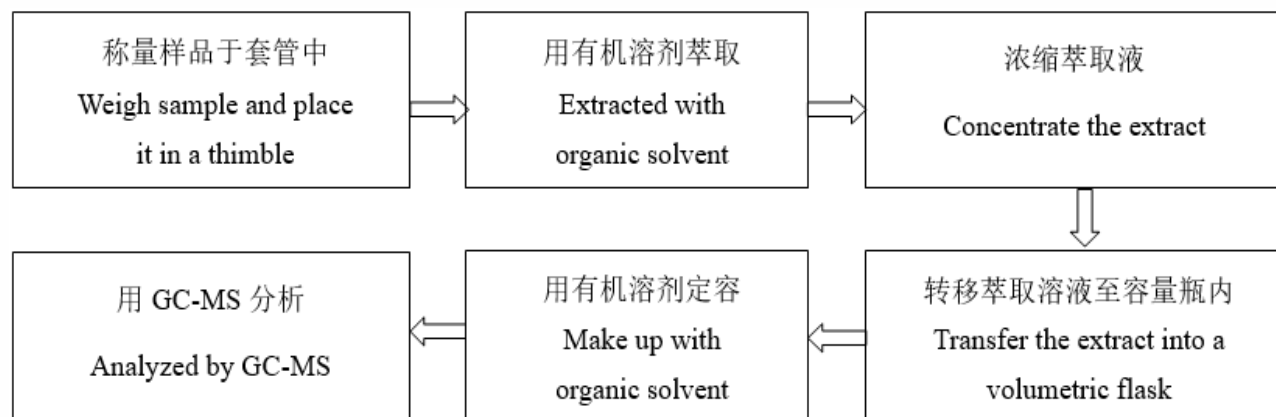

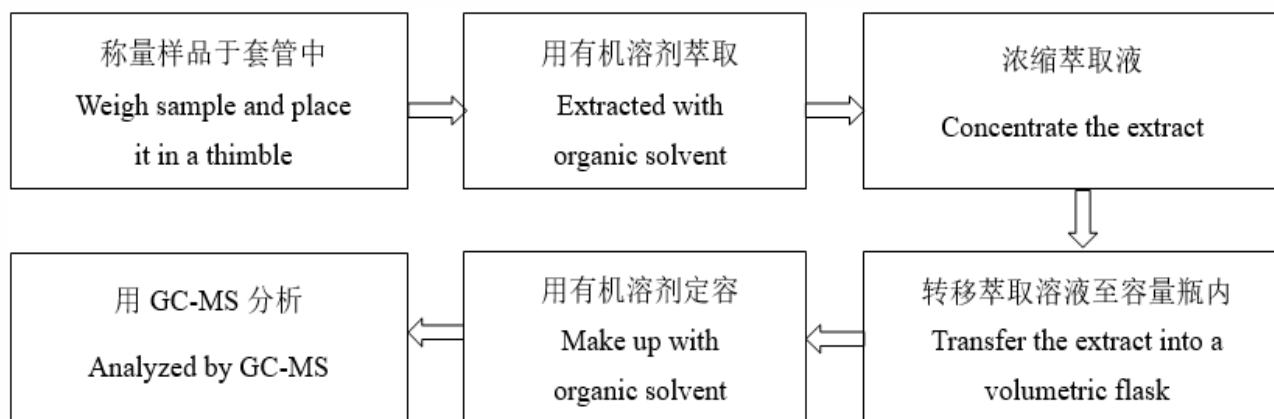

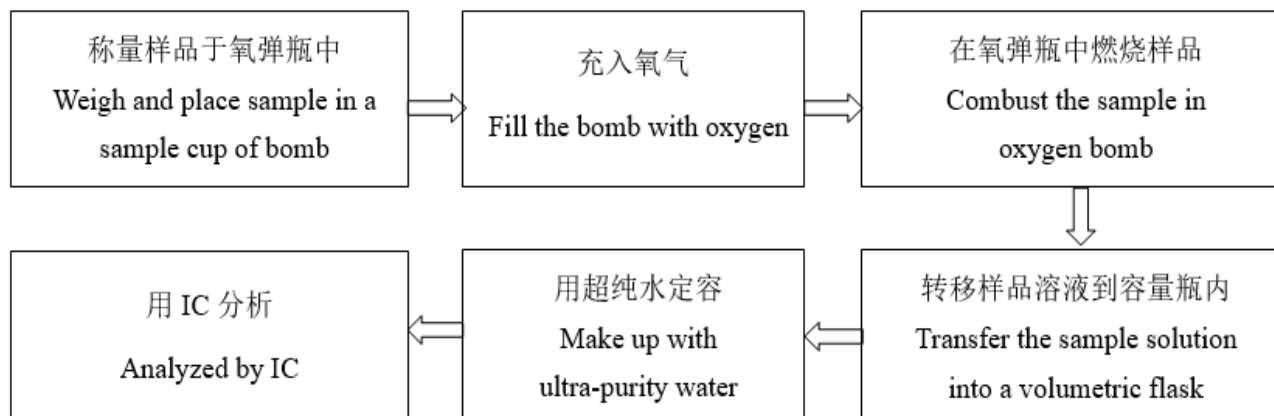
